Dear Friends,

Saint Elizabeth Community is a very special place. We've even been told that it's where magic happens.

When an elder in short-term rehabilitation or Home Care recovers from a surgery or a resident in Assisted Living makes new friends or discovers a new hobby - that's magical.

Take a look at our Annual Report as we share some highlights from across the community during the past year.

Our adult day centers now offer specialized programs for participants to address the needs of older adults facing early memory loss from conditions related to Alzheimer's disease as well as mobility issues related to Parkinson's disease. Our staff have participated in additional training, working closely with experts in both fields to deliver the best care possible.

We also include the caregiver in the process with support groups to leave them better equipped to look after their loved ones while providing respite, so they can have a break when they need it.

Hiring of healthcare workers remains a challenge but our CNA Training Program is thriving as we offer day and evening classes. This year, we added a new tool, a training manikin that mimics the symptoms and responses of ordinary people so students can practice before interacting with patients.

As many of our neighbors choose to age in place, our Home Care services continue to grow. We have an incredible team of nurses, CNAs and therapists who are providing compassionate care where people are most comfortable – in their homes.

Similarly, we are growing our offerings of Aging Life Care, formerly Geriatric Care Management. Saint Elizabeth's certified specialists walk their clients through the process of preparing for long-term care, whether for themselves or their loved ones.

SASH, Support and Services at Home, has expanded beyond Saint Elizabeth Apartments in Providence to other communities including Pawtucket and West Warwick with Woonsocket on the way. As a result, more older adults with health-related issues will be able to remain in their homes and stay well.

Both our skilled nursing home and assisted living have been acknowledged for their quality of care. Saint Elizabeth Home was

voted the number one nursing home in *The Providence Journal's* Community Choice Awards while Assisted Living was recognized by *Rhode Island Monthly's* Top Senior Living Awards.

The Haven for Elder Justice continues to address elder abuse and, as awareness of the issue continues to grow, we look forward to the development of a coalition of community-based organizations designed to tackle the problem head on.

With more of our friends and neighbors growing older, there are fewer opportunities available for care, as skilled nursing facilities and home care organizations in Rhode Island continue to close.

The economic crisis hitting nursing homes and the healthcare industry in general is worsening. With our older population increasing in size as well as the demand for specialized care due to diseases like Alzheimer's and Parkinson's, the outlook is not a positive one.

In the past several years, ten nursing homes have either closed or fallen into receivership, a trend that reduces the options for care.

It is often said that you can tell a lot about a society by the way they care for their vulnerable populations, the elderly in this case. At the moment, our lack of response to the needs of our seniors does not say much about our priorities.

As you can see by our Financial Review on page 25, Saint Elizabeth remains a strong and viable organization, yet we are faced with the same challenges as others in the healthcare industry. Thankfully, we are able to rely on the support and generosity of the families and friends in our network. We remain committed to providing the best care whether it's in your home or our skilled nursing home.

But we can't remain a beacon for compassionate elder care without you. Thank you for everything you do to help us maintain a thriving community, today and into the future.


