Saint Elizabeth Community works to provide exceptional care which requires we maintain strong staffing, and provide stimulating and enriching programs, so elders can feel supported and engaged.



In the pages that follow you will see the lists demonstrating the tremendous support Saint Elizabeth Community continues to receive from grateful families, friends, staff, foundations and government organizations. We are so thankful for every contribution.

Two programs that received grant support in 2018 include the SASH (Support and Services at Home) program at Saint Elizabeth Place which received a Tufts Foundation grant to continue to build and expand the program supporting independent seniors; and the Saint Elizabeth Haven for Elder Justice program which received a U.S. Department of Justice federal grant to help expand training and education about elder abuse, to raise awareness and help end this problem. These grants directly impact the quality of life for RI seniors, by supporting important programs and education.

Providing exceptional compassionate care and services to over 2800 individuals a year, mostly those 55+, and many whom rely on financial assistance to receive the care they need, is part of our mission. Rhode Island has a large percentage of seniors in our small state, and many of these Rhode Island elders need support as they continue to age.

We will strive to continue to be a trusted resource for care for seniors in RI, and to bring innovation and compassion to Rhode Island's older population.
